

2017 ECSCA National Boutique Rules

Persons May exhibit/sell their works by invitation only. A consignor must be suggested to the boutique committee by a club member, or may apply for an invitation in writing, by calling, or by emailing the boutique chairman with a description or examples of their work. Invitations will be sent to approved consignors no later than 3 months before the specialty.

Consignors are responsible for all shipping/handling costs, both incoming and return of unsold goods. The club will not be responsible for damages during shipping/handling of items.

Incoming shipments must arrive no earlier than April 25 and no later than May 1st, 2017. The Boutique Chairman reserves the right to refuse shipments prior to the mailing date of the invitations. No shipments will be accepted on the day of the show. Items may be hand delivered directly to the boutique during specific hours by prior arrangement with the Boutique Chairman.

All shipments must be accompanied by a completed inventory sheet provided in the information packet.

The club will retain 20% of the selling price of each item.

Each item must be clearly marked with the selling price (Consignors 80% + ECSCA's 20% = Selling price) and inventory number. All items should be marked with a tag and safety pin (best for clothes) or sticky labels.

Please price your items in even dollar amounts, such as \$5, \$25, etc.)

All items displayed must be English Cocker oriented. Having an English Cocker motif, be about English Cocker Spaniels, or be for the use of English Cocker Spaniels.

The Boutique Chairman will post the hours the boutique will be open. The club will furnish tables, display material, and sales persons. The club will pack/return unsold items and send the consignor a check for 80% of the selling price of all sold items less shipping costs within four weeks of the specialty date.

The boutique chairman reserves the right to assign/limit the amount of table space given to each consignor and limit the number of the same item that will be displayed.

ECSCA BOUTIQUE CONSIGNOR'S AGREEMENT

I agree to the following:

1. All items are packed, shipped, sent, and displayed at the consignor's sole risk. The ECSCA, the Boutique Chairman, nor the staff will be held responsible for damage or loss of consigned items through theft, fire, breakage, or any cause whatsoever.
2. No consignments will be accepted from the consignor's who have failed to complete and return this form by **April 15, 2017**.
3. A sales inventory form is included in this mailing. This form **MUST** accompany each box accepted by the boutique whether mailed or hand delivered. If you are shipping more than one box, please mark "Box 1 of 3" etc. so we will know how many should arrive. Please use your first, middle, and last initials on any price tags attached to merchandise.
4. **Consignors will be responsible for shipping sale items to be received prior to April 29th to Linda Amick, 4605 Lexington Rd, Athens, Ga. 30605 . Arrival after April 29th must go to the Crown Plaza Asheville, 1 Resort Dr, Asheville, NC 28806 All boxes must be marked "ENGLISH COCKER SPANIEL CLUB" in large print with a bright colored marker.**

5. Hand delivery of articles consigned to the boutique will be possible by advance arrangement only. Contact the Boutique Chair, Nancy Praiswater, to make these arrangements.
6. Records of all sales will be kept by the ECSCA and 80% of collected sales will be paid to the consignor within thirty days of the closing of the boutique.
7. Unsold items, not picked up by the consignor within 2 hours after the final judging, will be returned to the consignor by means of UPS, FedEx or Parcel Post at consignor's expense. Shipping charges will be deducted from the consignor's profits by the ECSCA Treasurer . Third parties picking up merchandise for a consignor must have signed permission from the consignor or prior arrangements made with the Boutique Chair.

8. Consignors are responsible for reproducing forms as necessary to complete the above arrangements.
