NOTICE TO EXHIBITORS

Entries close 5:00 pm Tuesday, April 18, 2017 at the Test Secretary's home.

Entry fees: \$130.00 which includes the AKC Recording Fee
{AKC recording fee is \$3.50 per entry/\$3.00 per additional dog}

Entries will not be accepted without fees.

Mail all entries to: Sue Cousart, Test Secretary, 1232 Peace Haven Road, Clemmons, NC 27102. Make checks payable to the English Cocker Spaniel Club of America (ECSCA). Please provide separate forms of payment for each dog entered in the test if you are entering multiple dogs.

Entries will only be accepted via U.S. Mail (No alternate carriers such as Airborne, FedEx, or UPS, etc.) All entries received non-U.S. Mail will be returned.

Entries will be accepted up until the official closing date, even though the advertised limit has been reached, and a drawing will be held to determine which entries will participate in the Tracking Test.

Entries will be drawn at the Test Secretary's home at 5:00 pm Tuesday April 18, 2017. Any interested persons may attend. The drawing shall be completely at random among all entries received, except that preference shall be given to those English Cocker Spaniel dogs that have not previously earned a Variable Surface Tracking title (VST) followed by English Cocker Spaniel dogs with a VST, followed by all other breeds without a VST, followed by other breeds with a VST. When the advertised limit has been drawn, all remaining entries, subject to the same preference set forth, shall be assigned a position on an Alternate List corresponding to the order in which they were drawn.

Results of the drawing for entries. Entrants will be contacted by email and/or telephone between the hours of 5:00 pm and 9:00 pm (EDT) on Tuesday April 18, 2017 advising them of the results. Alternates will be given the opportunity to accept or decline the alternate position. All those submitting entries are requested to be personally available (or provide a designated agent) to receive this notification.

Errors on entry blanks. Owners are responsible for errors in making out forms, whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellations of entries after the published closing date.

Unsigned entries cannot be accepted. Entries not on Official AKC Entry Forms and photocopies of Entry Forms without the Agreement and Rules on the reverse side of or attached to the Official AKC Entry Form are not acceptable.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Entries cannot be accepted, canceled, altered, or substituted after the entries have closed.

No refund of entry fees after entries close and drawing of tracks except:

- 1) Fee (less \$3.50 for AKC recording fee) of drawn entrant who notifies the Test Secretary of withdrawal prior to test date, provided an alternate is available to fill the vacancy
- 2) Full refund of alternate entry fee if alternate does not participate.

Refund will be made within 7 days of event.

Bitches in season may participate. Please notify the Test Secretary and Judges prior to the drawing for the tracks. The last track(s) to be laid shall be reserved for the bitch(es) in season. Parking space will be provided away from the general tracking area to minimize any disturbance to any male dogs entered in the test.

A judging program will be emailed to entrants and alternates following the drawing for the entries.

Handlers should assemble at the Haywood Community College 185 Freedlander Drive, Clyde, NC 28721 at 7:45 AM for the drawing of the tracks. The first track will be run following the draw.

Directions to the Hayward Community College from Asheville:

Get on I-240 West. Take Exit 31B to merge onto I-40W towards Canton/Knoxville. Drive approximately 18 miles. Use the right 2 lanes to take Exit 27 for US-74 toward US-19/US-23 (Waynesville, Maggie Valley, etc.). Continue onto US-74W. Drive 1.0 miles and take Exit 107 toward E. Jones Cove. Drive 0.2 miles and merge onto US-19S/US-23S. Drive 0.2 miles and turn Left onto Jones Cove Road. Slight left onto Freedlander Drive. Turn left into the first parking lot.
